Personal data processed by us

We respect your privacy and ensure that the personal information you provide us with is treated confidentially. Processing of personal data takes place in accordance with the requirements stated in the General Data Protection Regulation. This privacy statement describes how Prokol handles your personal data.

We process your personal data on the basis of the following fundamental principles:

For what purpose do we process personal data?

Special and/or sensitive data processed by us

Cookies or similar techniques used by us
